NOTIFICATION

No. Med-XXI-A-02/2013 - 2 3 0 7 4/H., Dated the 12th August, 2013.

The following Medical Officers are appointed as Asst. Surgeon in Class-I (Jr.) of the State Medical and Health Services Cadre on adhoc basis in the scale of pay of Rs.15,600-39,100/- + G.P. Rs.5,400/- with other allowances as sanctioned by Government from time to time for a period of one year with effect from the date of their joining to the places as mentioned against each with the following stipulations.

2. The appointments are purely temporary and terminable at any time without prior notice and without assigning any reasons thereof.
3. The MOs from Sl. No.14 to 24 shall produce the pass certificates of Odiya ME standard within 6 (six) months from the date of their joining, failing which, their services shall be terminated.
4. The list of selected adhoc doctors is available in the departmental website http://www.orissa.gov.in/health_portal/index.html. The appointees are requested to down load the copy of order from the website and produce the same before the CDMO concerned for their joining.
5. The appointees should join in their places of posting within one month from the date of issue of the posting orders failing which, their appointments will stand automatically cancelled.
6. The CDMOs concerned will inform the date of joining of the above MOs to this Deptt. immediately.
7. No T.A. / D.A. is allowed to the candidates to join the appointments.
8. They should produce the following documents/certificates before the CDMOs concerned at the time of their joining :
 - (i) Original MBBS pass-out certificates.
 - (ii) Housemanship completion certificate.
 - (iii) Medical Registration Certificate as required under Odisha Medical Registration Act, 1961.
 - (iv) 2 nos. of Conduct Certificate.
 - (v) One Medical Fitness Certificate at the time of reporting to the concerned Chief District Medical Officer for verification.
 - (vi) An undertaking regarding one spouse living if married.
