In this regard we would like inform you that if the monthly payment will be calculated on the calendar days then the EPF should be quoted on ceiling wage or on total wage, kindly clarify the same. And further we would also like to bring your kind attention that as per the new labour code if an employee completes one year of service in any organization he/she would entitled to get the statutory dues like Leave, N.H. & F.H., gratuity etc. Kindly clarify the same,	Please refer to the revised Financial Bid Format enclosed in Corrigendum-I.
